Presidents Notes

I would like to thank last year's president Janet Owen and her husband, Jerry for their hard work and commitment to Vintage Birds. If your Blue Bird breaks down and Jerry is nearby, he just may have what you need for the repair. (I and many others can attest to that!) Thanks again Janet and Jerry!

Our hats are off to Curt Sprenger and Phil Corpus of Southwest Blue Birds for hosting their third annual Quartzite rally in Quartzite, Arizona. Over sixty Blue Birds were in attendance which included twenty three Vintage Bird members. There were also a number of SOBs. The rally ran for nine days from January 17 to the 25 and is dry camping only on land owned by the Bureau of Land Management (BLM). Water and dump facilities are available. A full itinerary of activities were planned by attendees with adequate time for relaxing. This year, Vintage Birds funded a wine and cheese tasting party and we thank Dan & Cindy Sunderland (Vintage Birders) from San Marcos California for hosting the event for our chapter. Thanks guys.

We almost never talk about finances, but with the year end treasurer's report in hand, it appears we are in good financial condition. Dues and memberships for 2008 amounted to \$4005 while corresponding expenses were \$3,374. On years when we publish a directory our expenses will increase. At year end we had cash of \$14,450 plus a CD of \$10,130. Please look at your mailing label and note the date in red ink. If the date is 2008 and you have not recently mailed a check, you annual dues in the amount \$10 are now payable.

Our membership number is frequently open to interpretation because of delinquent dues status but as of year end I can confirm we have three hundred seventy five members which includes twenty new members for the year. The membership number excludes those members whose names were expunged because of serious dues delinquency. Attesting to our longevity, we still have some members with single digit membership numbers.

Organizing rallies has been particularly difficult over the last two years because of the price of diesel and the general economy. However, I am happy to report there are three rallies in the planning stage and we will bring you more information as events begin to gel.

To be eligible for membership, you must first be a member in good standing of FMCA. Then you must own a Blue Bird Wanderlodge or BMC five years old or older. For example, a 2000 coach would be eligible in the fall of 2004 when the 2005 models go on sale. If after joining the Chapter, should you purchase a later model Wanderlodge, you may still remain a member of the Chapter. The purpose of the Chapter is to provide a forum for exchange of ideas concerning the maintenance or modification of Blue Bird Wanderlodge Coaches or BMC. The Chapter will also provide fellowship among owners, conduct interesting and affordable rallies. The initiation fee is \$25.00. This will cover your Chapter name badges and the first year's dues. After the first year the Annual Dues are \$10.00


